Alliance Gertz-Ressler Richard Merkin 6-12 Complex created its ESSER III Expenditure Plan through meaningful engagement and consultation with its principal, scholars, parents, and classified and certificated school site staff through their School Site Advisory Council (SSAC). School leadership worked with Alliance's Home Office instructional and social-emotional experts to initially identify budget needs and areas of concerns for each school. School leadership then hosted an SSAC meeting to receive feedback from all community member groups on how to best use one-time funds to help safely reopen and operate, while addressing the impact of the coronavirus pandemic on our scholars. The perspectives and insights provided by community members allowed for the determination of important and effective programs and services to implement. These recommendations were used to create the ESSER III Expenditure Plan, which was then made available for additional comment and input by any members of the public before the final version was reviewed by the governing board for approval.

As described above, the community members of Alliance Gertz-Ressler Richard Merkin 6-12 Complex provided significant input and direction in developing the ESSER III Expenditure Plan. The allocation of funds between Strategies for Continuous and Safe In-Person Learning, Addressing the Impact of Lost Instructional Time, and the use of remaining funds for Mental Health Supports reflects the community's identified priorities in supporting and protecting scholars over the coming years. However, the community also recognizes that priorities may shift as we continue to address the changing and newly emerging needs of scholars.

English Language Proficiency Assessments for California (ELPAC) will be used for English Language Learners (ELLs). Local reading, phonics (WIST) and curriculum-based assessments will also be used. These assessments, in conjunction with attendance data and teacher recommendations, will help to identify and understand the needs of our scholars, including those that will need supplemental instruction and support in addressing unfinished learning. Particular	i-Ready assessments will take place three times each school year. Summative ELPAC assessments will take place at the end of the year, the end of the semester, and at the end of a course.

- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.
